DIGI-FACE Cross-disciplinary Modules

All DIGI-FACE Cross-disciplinary Modules are produced as Open Educational Resources (OER). As such these modules are distributed under the Creative Commons License [CC-BY-SA](#).

Practically this means that:

- anyone can use any section of the content that forms part of the cross-disciplinary modules,
- anyone can use the cross-disciplinary module as a whole,
- anyone can use the structure of the cross-disciplinary module,
- anyone can use its methodology and any part of it,
- anyone can adapt the cross-disciplinary module to their specific needs.

These actions can be taken freely and without any charge, under two conditions:

- 1 the user must **name the authors** of the cross-disciplinary module (when in doubt use "DIGI-FACE"), add a link to the license ([CC-BY-SA](#)) and provide information on any changes that may have been made and
- 2 the user must **grant the same distribution rights** under the same conditions to anybody using the (adapted) module or parts thereof; this means that the content must be distributed under the CC-BY-SA license or a [compatible license](#).



CONTENT UPLOADED ONTO DIGI-FACE BY ITS USERS

Copyright /Intellectual Property (IP) on DIGI-FACE

- The IP follows the same rules and regulations that apply to the institution a user belongs to.
- In most cases, this means that the **intellectual property** lies with the author or the institution the author is part of, depending on the law of the respective country.
- DIGI-FACE does not assume any ownership or right of use whatsoever of the content uploaded by users.



DIGI-FACE is merely providing the platform for the content. The content remains the **property of the author** or their institution.

- Unless stated otherwise, nobody is entitled to use anything that has been put online without the consent of the author.
- However, the author can choose to **upload content** under a [creative commons license](#) (CC). In this case, the author should mark the content accordingly. Any user the author has granted access (e.g. students enrolled in a course) will then be allowed to use the content according to the respective license selected.



Please note: DIGI-FACE does not take technical measures to protect authors' content, other than limiting access to courses by passwords or respective enrolment methods.

- Effectively this means that no-one is able to enter a course and to access the content published in a course unless the author/manager allows them to do so. If however the author/manager has allowed **(enrolled)** somebody in a course, there are no technical mechanisms in place to limit the use of the content in the course.

Notice and take-down policy (Concerning IP of third parties)

- » DIGI-FACE merely provides the platform. This means that DIGI-FACE is not in the position to check and control each and every item of content that is uploaded for possible violations of intellectual property or copyright infringement.
- » DIGI-FACE follows a notice-and-takedown policy. Anyone who claims that uploaded content infringes their intellectual property or copyright can notify DIGI-FACE about this by contacting digiface@hs-kehl.de or by using the [contact form](#).
- » DIGI-FACE will then evaluate the claim. Pending evaluation, access to the content allegedly infringing copyright will be suspended. If the claim is sustained after evaluation the content will be permanently removed from the platform.
